#### Sustainability Working Group Briefing



Each year the Global Shea Alliance convenes a bi-annual sustainability-working group to address challenges to the empowerment of women shea collectors and the conservation of shea tree populations across Africa. The working group is made up of a representative mix of GSA members and partners from all levels of the shea value chain. The working group met this year in Tamale, Ghana from 10 - 11 November and

elected new SWG Chair Anna Perinic (Star Shea Ltd., Ghana) and Co-Vice-Chairs Funlayo Alabi (Shea Radiance, United States) and Fatoumata Coulibaly (Karinor, Ivory Coast).

During the meeting, SWG members visited sustainability partners Presbyterian Agriculture Services, Tungteiya Women's Group, and SeKaf Shea Butter Village to discuss best practices for the warehouse, parkland management, and conservation pilot project work streams. Members also reviewed program reporting procedures, partner and secretariat communication, fundraising and private-public partnership opportunities, as well as a consumer-facing GSA membership mark. The working group will make a presentation on its activities during the upcoming General Assembly at Shea 2016.

#### USAID Warehouse and Business Training Update

The GSA in partnership with the West Africa Trade Hub has completed the first phases of a year long Warehouse and Business Training project. The purpose of the project is to build warehouses and provide trainings to establish sustainable women-led warehouse management systems with fifteen of GSA's sustainability partners. So far, the partners have trained 695 women on cooperative development, and built 20 warehouses.
